**RESOLUTION 2019-35**

**Rescinding Resolution 2019-12 Calling for the formation of Metropolitan Park District**

**WHEREAS**, the Board of County Commissioners passed Resolution 2019-12 on April 16, 2019 calling for the creation of a Metropolitan Park District; and

**WHEREAS**, a similar resolution was passed by the City of Stevenson; and

**WHEREAS**, the creation of such a park district requires review by the Boundary Review Board; and

**WHEREAS**, the Boundary Review Board took initial public comment regarding the boundaries of the district; and

**WHEREAS**, the hearing revealed that there is much confusion regarding the nature of the park district and the rationale for its boundaries; and

**WHEREAS**, we believe the County and the City can make a clearer record of the purpose and limitations of the district as well as the rationale behind the proposed boundaries and ease the burden on the Boundary Review Board; and

**WHEREAS**, rescinding the resolution today will allow the Boundary Review Board to review a future proposal that is clearer; and

**NOW, THEREFORE, BE IT RESOLVED** that the Skamania County Board of Commissioners rescinds Resolution 2019-12, asks the City of Stevenson to rescind their resolution, and asks the Boundary Review Board to no longer consider the current proposal.
