

**RESOLUTION 2016-39**  
**(Establishing Legal Holidays for 2017)**

**BE IT HEREBY RESOLVED**, by the Board of County Commissioners that pursuant to RCW 1.16.050 and Skamania County Code Chapter 2.48 Personnel Provisions, Skamania County shall observe certain days as legal holidays for the calendar year 2017 in observance of the event, individual, or official noted.

**BE IT FURTHER RESOLVED** that offices that are on a four-day work week, Monday through Thursday, shall be closed on the following days/dates:

Monday	December 25	Christmas Day


**BE IT FURTHER RESOLVED** that the following collective bargaining units shall observe holidays as set forth in their respective agreements.
