Bids received after 4:00 o'clock p.m., Tuesday, Feb. 13, 2018 will not be considered.

This project shall consist of: Grinding of asphalt, asphalt overlay 1.5", and restriping line and other work along portions of Washougal River Road and Cook-Underwood Road.
