Public Service Display Fact Sheet

The Skamania County Fair and Timber Carnival will be held **August 14 - 17**. We invite you to join us for another great celebration!

To qualify for these spaces, your organization must be an incorporated charitable non-profit, or a government agency. **Note: public service does not include political organizations.**

Public Service Booths must adhere to the following guidelines:

- Booth space is 10' x 10'. The Fair provides space, only. Participating agencies will provide any booth components or contents: i.e. tent (and method to protect tent from wind), tables, chairs, etc.
- There is a \$25.00 fee for booth space. To register, complete the attached application, hold harmless agreement, and enclose your payment. Please make checks payable to: **Skamania County**.
- Applications are due no later than June 1st. Space is limited. **Booths will be assigned on a first-come first-served basis.**
- Fair Board policy prohibits raffles or any type of cash based fundraising contest within the public display area.
- **Booths may be setup on Tuesday after 6PM or on Wednesday morning. Booth must be complete by 11AM on Wednesday, August 14.**
- **Wednesday and Thursday, we require that your booth is set up with literature but does not need to be staffed. We require booths be staffed during all Fair hours of operation on Friday and Saturday. Failure to abide will forfeit future participation in the Skamania County Fair.**

The Skamania County Fair draws approximately 20,000 visitors each year. The public display booths are an excellent venue for educating the community, about the good works of your organization.

Should a lawsuit in respect to the above be filed, the Participant/User shall appear and defend Skamania County at its own expense, and if a judgment is rendered or settlement made requiring payment by Skamania County, its officials, employees, volunteers or agents, the Participant/User shall pay the same.
